

CROWD PLEASERS DANCE HAS ALWAYS BEEN COMMITTED TO PROTECTING THE HEALTH AND SAFETY OF OUR PARTICIPANTS, DIRECTORS, SPECTATORS AND EMPLOYEES. WE WILL CONTINUE TO MONITOR AND FOLLOW THE CURRENT STATE/LOCAL AND THE CENTER FOR DISEASE CONTROL (CDC) GUIDELINES.

FACILITIES

- FACILITIES WILL BE CLEANED AND SANITIZED PERIODICALLY THROUGHOUT THE EVENT.
- THERE WILL BE A MID-DAY BREAK FOR SANITATION AND TO EMPTY THE PERFORMANCE SPACES.
- SPECTATOR SEATING WILL BE ADJUSTED FOR PROPER SOCIAL DISTANCING.
- SEPARATE EVENT TRAFFIC FLOW FOR SPECTATORS AND PARTICIPANTS WILL BE CAREFULLY DESIGNED TO ELIMINATE ANY POSSIBLE CONGESTION IN THE HALLWAYS.
- ADMISSION AND PERFORMANCE AREA ACCESS WILL BE BASED ON PRE-SOLD WRISTBANDS ACCORDING TO THE PERFORMANCE BLOCK.

SPECTATORS

- TWO WRISTBANDS WILL BE ALLOCATED PER DANCER. (NO ONSITE WRISTBANDS WILL BE AVAILABLE FOR PURCHASE.)
- THE NUMBER OF WRISTBANDS DISTRIBUTED WILL BE LIMITED/MONITORED TO ABIDE BY THE STATE AND/OR LOCAL CAPACITY REQUIREMENT.
- ONLY THOSE WITH A WRISTBAND ASSIGNED TO THE SCHEDULED PERFORMANCE BLOCK WILL BE PERMITTED ONSITE.
- THE MAIN GYM MAY BE LIVE-STREAMED FOR A VIEWING FEE TO ACCOMMODATE VIRTUAL SPECTATORS.
- VARIOUS VIEWING AREAS MAY BE PROVIDED THROUGHOUT THE EVENT.
- ALL SPECTATORS WILL BE REQUIRED TO WEAR A FACEMASK AND ABIDE BY THE PROPER SOCIAL DISTANCING PROCEDURES.

SCHEDULING

- AM AND PM PERFORMANCE BLOCKS WILL BE IMPLEMENTED TO ABIDE BY THE FACILITY CAPACITY REGULATIONS.
- EXPECT TO HAVE LIMITED TIME BETWEEN PERFORMANCES. (ABOUT 10-30 MINUTES)
- OFFICER, SOLO, DUET AND TRIO PERFORMANCES MAY BE SCHEDULED IN A SEPARATE PERFORMANCE BLOCK, PLEASE CONSIDER THIS WHEN ARRANGING YOUR TEAM TRANSPORTATION. (YOU WILL BE NOTIFIED 4 WEEKS IN ADVANCE.)
- OFFICER, SOLO, DUET AND TRIO PERFORMANCES MAY BE HELD IN THE AUDITORIUM. (YOU WILL BE NOTIFIED 4 WEEKS IN ADVANCE.)

PARTICIPANTS

- PARTICIPANTS WILL ONLY BE ALLOWED IN THE BUILDING DURING THEIR SCHEDULED PERFORMANCE BLOCK.
- DRESSING ROOM CAPACITY WILL BE ADJUSTED TO HELP COMPLY WITH SOCIAL DISTANCING PROTOCOLS.
- ALL PARTICIPANTS WILL BE REQUIRED TO WEAR A FACEMASK AND ABIDE BY THE PROPER SOCIAL DISTANCING PROCEDURES - EXCEPT WHILE PERFORMING.

AWARDS

- WE ARE PLANNING FOR A CONTACTLESS AWARDS PROCESS.
 - FOR OUR IN-PERSON EVENTS, THERE WILL BE A "POINT OF CONTACT" TO PICK UP YOUR AWARDS FOLLOWING THE LAST PERFORMANCE OF THE DAY.
 - FOR OUR VIRTUAL EVENTS, AWARDS WILL BE MAILED PRIOR TO THE SCHEDULED LIVE STREAM DAY.
- AN AWARDS PRESENTED SUMMARY WILL BE EMAILED TO EACH DIRECTOR DIRECTLY FOLLOWING THE CONTEST.
- SOCIAL MEDIA HIGHLIGHTS OF THE WINNERS WILL BE POSTED THE WEEK FOLLOWING THE CONTEST.
